ance or in need of some adjustment to provide for greater efficiency. As *Provider* is still conducting trials, the total amount to be spent on these deficiencies and adjustments is not yet completely known, but it is expected that a proportion of such costs will be borne by the shipbuilder under the terms of the warranty agreement.

3. Yes. In company with H.M.C.S. Yukon, Provider is carrying out trials to bring her replenishment system to a fully operational and worked up state, as well as carrying out fleet exercises. In addition, *Provider* will visit Newcastle-on-Tyne to instal certain items of replenishment equipment which are being replaced under warranty by the equipment manufacturer.

WORLD FAIR REGIONAL REPRESENTATIVES

Question No. 1,180-Mr. Latulippe:

1. How many regional representatives of the 1967 world exhibition have been appointed to date? 2. What are the names of those representatives?

3. What regions do they represent?

4. What are their general functions?

5. How many offices will be opened for those representatives?

6. Where and when will those offices be opened? 7. What amounts are provided toward the administration of those offices?

8. Is a special system of representation provided for with municipal councils by those regional offices for the purpose of municipalities participating to any program concerning the exhibition?

9. Have any Canadian embassies assigned personnel to promote the exhibition abroad?

10. Have the directors of the 1967 world exhibition corporation examined, or are they examining, the possibility of creating regional committees, for instance, one for the eastern townships, one for the northwest district of Quebec, in all provinces, in order that the whole of the Canadian population may participate?

Answer: 1. Three.

2. Allan A. Rowan-Legg, Squadron Leader T. J. MacKinnon and Major General Edward Chester Plow.

3. They do not represent any region in particular but rather the 1967 world exhibition in the following regions: Rowan-Legg: Ontario, Major General Plow: Atlantic provinces, MacKinnon: British Columbia.

4. In their respective regions, they will help the world exhibition by keeping in touch with exhibitors, looking after public relations and, during the exhibition, visitors to the exhibition on tour in Canada, especially important people and foreign businessmen.

5. Three for the abovementioned representatives and a fourth one in Winnipeg, for the prairies, in 1964. The opening of other offices is also contemplated.

6. Vancouver on June 15, 1964, Toronto on June 1, 1964, Halifax on June 15, 1964, Winnipeg has not been opened yet.

7. \$173,000.

8. Proposals concerning the participation of municipalities as exhibitors are submitted to the provinces concerned. The corporation deals directly with local groups with regard to public relations.

9. Canada's embassies abroad have no personnel specially responsible for promoting the 1967 world exhibition, but all our ambassadors and high commissioners as well as their staff receive documentation about the exhibition and do their best to promote it in the countries where they are posted.

10. Yes, but only where the initiative is taken at the local level.
