PROHIBITION ON SALE OF CANADIAN TURBOT IN U.S.

Mr. James McGrath (St. John's East): Mr. Speaker, I have a question for the Minister of Trade and Commerce. Can the minister tell the house what action his department contemplates regarding the recent prohibition by the U.S. food and drug administration of the sale of Greenland halibut on the U.S. market and the disastrous consequences it has had on the Canadian east coast fisheries?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, as was mentioned by the Secretary of State for External Affairs last Friday, we made representations on this subject to the United States. I have been informed that the food and drug administration will hold hearings on this subject on October 2 in order to receive representations from all parties. We are in touch with the fishing industry of Newfoundland on this subject, and we are doing our best to bring their case before the U.S. authorities.

Mr. McGrath: Could the minister inform us what role his department will play when this appeal is heard in the United States?
