Robert Stanbury (Minister of National Revenue): According to our records, the gross revenue derived from excise duties and excise taxes on the sale of alcoholic beverages for the fiscal years 1972-73 and 1973-74 was as follows: 1972-73: \$426,152,652.30; 1973-74: \$452,477,328.41. The above amounts do not include revenue from the consumption or sales tax imposed by the Excise Tax Act, as such revenue is recorded in one account without any distinction as to source.

These events will conclude on June 7 and the delegation will return to Canada the next day. The Department of Veterans Affairs has communicated with the Mayor of Saint-Georges-des-Groseillers, and has offered to assist the survivors of the Canadian units concerned to visit his community while they are in Normandy.
