Also, is he aware of the concern of other police forces in Canada about this matter, and what steps are being taken by him and, to his knowledge, by the attorney general of British Columbia to evaluate the situation?

Hon. J.-J. Blais (Solicitor General): Mr. Speaker, I thank the hon. gentleman for bringing all those facts to my attention. I will look at the information he has provided, and if his evidence is accurate I will express the concern that he has expressed.

#### REGULATIONS RESPECTING CHARITABLE ORGANIZATIONS

Hon. Monique Bégin (Minister of National Health and Welfare): Mr. Speaker, I would appreciate it very much if the hon. member would be kind enough to repeat his question. I shall gladly answer him.

Mr. Munro (Esquimalt-Saanich): Mr. Speaker, it seems to me that the minister represents Revenue Canada in this House, and I should like to know the present status of document No. 78-3 dated February 27, 1978, and entitled "Registered Charities—Political Objects and Activities".

Miss Bégin: Mr. Speaker, as far as I can remember—but I will gladly check with the Minister of National Revenue for further details—the document is entitled "Information Circular". These are documents relating to income tax that are issued regularly and distributed to all accounting firms and tax experts. In this case, it was sent to all charitable organizations, of which there are about 40,000, if I am not mistaken, and which are given tax concessions for charitable donations.

Mr. Munro (Esquimalt-Saanich): I wish to ask a supplementary.

If I remember well, the Prime Minister has suspended the document concerned. I should like to know whether, according to the answer the minister gave us a few moments ago, the document's status is actually the one it has today.

Miss Bégin: I am sorry but I was not in the House for a few days. If the Prime Minister has suspended that document, I cannot see why the hon. member bothers to ask me a silly question.
