Does he challenge the statement made in this transcript by the Deputy Prime Minister that he was listening to—"I was hearing and I was hearing every word that was spoken"—the caucus while it was going on, and that that is within the meaning of "intercept" in the Criminal Code?

**Right Hon. Brian Mulroney (Prime Minister):** Mr. Speaker, that is an interpretation that my hon. friend places on a construction of events. The Deputy Prime Minister has indicated that the incident which transpired was one in which he was entirely blameless with regard to the initiation thereof or any resonsibility flowing therefrom, on the one hand. Second, with regard to the point raised by my hon. friend regarding a member of the Royal Canadian Mounted Police, it is true, and I indicated it earlier, that the timeliness of this is not affected by the passage of time, but in the case of the member of the RCMP a charge was laid. If my hon. friend feels that something is illegal, he ought to lay a charge and assume the consequences.

Hon. Bob Kaplan (York Centre): Mr. Speaker, let me simply ask the Prime Minister this. Is it acceptable today among his Ministers for them to intercept, that is, to listen to discussions which are going on in the Liberal caucus or in the NDP caucus? **Right Hon. Brian Mulroney (Prime Minister):** Mr. Speaker, I don't read anybody else's mail, I don't open brown envelopes, nor do I make unsubstantiated allegations against people without having the courage to stand up and put my seat on the line.
