## GOODS AND SERVICES TAX

Ms. Albina Guarnieri (Mississauga East): Mr. Speaker, my question is directed to the Minister of National Health and Welfare.

The current nursing shortage has forced many nursing homes to rely on medical service companies to provide their nursing and support staff. As a result most of the labour cost of these homes will be subject to the 7 per cent GST. Nursing homes expect to have no option but to pass this cost on to their patients.

She knows full well that sitting before the Senate right now is legislation that would allow cheques to go out to millions of low income Canadians as part of the GST tax rebate. If her colleagues who are barricading that in the
