

of loans, purchases of preferred shares by which the authorized capital of the Corporation is thereby increased, and that the Crown may guarantee securities issued by the Corporation, provided that the aggregate of such loans, guaranteed securities and preferred shares shall not exceed \$1,000,000,000; to provide for the sale to the Corporation of the whole or any part of the capital stock of Panarctic Oils Ltd. held by the Crown for cash, shares and securities of the Corporation provided that in full or partial payment for such capital stock, the Corporation may issue at par common shares of the par value of \$5,000,000 and thereby increase its authorized capital; to provide in the manner prescribed for the Corporation to receive and administer appropriations from Parliament; and to provide for the appointment of auditors.

We, Her Majesty's most loyal and dutiful subjects, the House of Commons of Canada, in Parliament assembled, beg leave to offer our humble thanks to Your Excellency for the gracious Speech which Your Excellency has addressed to both Houses of Parliament.

And on the motion of Mr. Stanfield, seconded by Mr. Wagner, in amendment thereto,—That the following words be added to the Address:

"We respectfully suggest to Your Excellency that the failure of your Ministers to act resolutely after the election of July 8th, last, has contributed to the increasing disparity and the social and economic disarray in the country, which require prompt, decisive leadership which is lacking in the Speech from the Throne."

And on the motion of Mr. Broadbent, seconded by Mr. Knowles (Winnipeg North Centre), in amendment to the said proposed amendment,—That the amendment be amended by changing the period at the end thereof to a comma, and by adding immediately thereafter the following words:

"and we regret in particular the failure of Your Excellency's advisers to make immediate proposals to assist those who are hardest hit by inflation, and also their failure to take immediate steps to increase the production of necessary goods and services and thus reduce the unemployment that so seriously affects the lives of so many of our people."

And debate continuing;
