MESSAGE OF LOYALTY AND AFFECTION

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I move, seconded by the hon. Leader of the Opposition, that a humble address be engrossed and presented to Her Majesty the Queen, in the following words:

BUSINESS OF THE HOUSE

REINSTATEMENT ON ORDER PAPER OF CERTAIN BILLS

Mr. Speaker: Order. Members will recall that on July 22, 1977, the House adopted Standing Order 117 which made an order respecting Bills C-7, C-17 and C-40 of the Second Session of this thirtieth Parliament and their reinstatement on the Order Paper in this the Third Session.

Accordingly, it is my duty to inform the House that, pursuant to Standing Order 117:

Bill C-2, an Act respecting the administration and development of certain fishing and recreational harbours in Canada, is deemed to have been read a first time, ordered to be printed, read a second time and referred to the Standing Committee on Fisheries and Forestry.

Bill C-3, an Act respecting the reorganization of Air Canada is deemed to have been read a first time, ordered to be printed, read a second time, referred to and reported from a committee and ordered for consideration at report stage.

Bill C-4, an Act to amend the Aeronautics Act is deemed to have been read a first time, ordered to be printed, read a second time and referred to the Standing Committee on Transport and Communications.

RECONSTITUTION OF COMMITTEE
