Mr. Speaker: Order, please. The question as asked by the hon. member comes close to being an argument. However, perhaps the minister might want to reply.

Mr. Munro: The most recent surveys we have had from the department indicate that they are not at levels such as to constitute a danger in the terms described by the hon. member.

FIR PLYWOOD-DIFFERENCE BETWEEN CANADIAN AND U.S. PRICES

I wonder if the minister can assure the Canadian people that he will investigate the difference in the cost of U.S. fir plywood, which is approximately \$40 per thousand cheaper than Canadian fir plywood, and would he also investigate the possibility that the B.C. Plywood Association is not maintaining prices for the manufacturers, thus milking the Canadian public?

Hon. Ron Basford (Minister of Consumer and Corporate Affairs): Mr. Speaker, I would be happy to look into this matter, although I understand that Canadian, and particularly B.C. plywood, is far superior to U.S. plywood.

Mr. Lind: I realize that some grades of U.S. fir plywood are inferior to our Canadian plywood, but their waterproof plywood, I should like to point out to the minister, is of far better quality.
