Sir,—With further reference to your note No. 687 of August 14, 1923, in regard to the alleged pollution of the St. Clair River in the vicinity of Sarnia by oily waste discharged into the Black River which flows into the St. Clair River, I beg to transmit herewith copies of a letter

from the Governor of Michigan, dated September 28, 1923, and its enclosure, a report of the investigation of the alleged pollution made by the Health Department of the State of Michigan.

or of Michigan, was It is stated in the report that the inspection resulted in finding that no appreciable amount of oily waste was being discharged into the Black River except from the plant of the Detroit Edison Gas Company and that while the oily waste from that plant made a clearly defined path in the Black River until it reached the St. Clair River no trace of oil could a nuisance alleged be distinguished in the St. Clair River beyond a distance of about two hundred feet from the American shore although at the time the inspection was made there was a fair current in the Black River going out to the St. Clair River and the wind was favourable for carrying floating substances toward the Canadian shore. The report also shows that no cily refuse of the character discharged from the plant of the Detroit Edison Gas Company was seen upon the Canadian shore although oil of a different character was seen on the St. Clair River near the Imperial Oil Company's refinery near Sarnia in Canada.

It is further stated that every effort will be made to prevent the further discharge of wastes from the plant of the Detroit Edison Gas Company and a recommendation is made that an investigation of the complaints regarding the alleged pollution of the river be made by a committee composed of the Sanitary Engineer of the Province of Ontario and representatives of the International Joint Commission and the Health Department of the State of Michigan. This Government is willing, if the Canadian Government so desires, that an investigation shall be made in the manner suggested by the authorities of the State of Michigan.

As the matter appears to be one in regard to which the International Joint Commission would have authority to make an investigation and report under Article IX of the Boundary Waters Treaty of 1909, the United States would be glad to join the Canadian Government in a reference to the Commission, if the Canadian Government should prefer that the investigation be made in this way.
