

And that two successive different returns dated respectively on the 19th day of November and the 23rd day of December, 1925, were received from the returning officer for the electoral district of Huron North, the first of the said returns having been received on the twenty-sixth day of November and the second on the twenty-third day of December,

And that the said successive returns were in the following terms, namely:—

"I hereby certify that the member elected for the electoral district of Huron North in pursuance of the within written writ, as having received the majority of votes lawfully given is George Spotton, teacher, Wingham, Ont. By judge's certificate. Dated at Goderich, this nineteenth day of November, 1925.

"The election documents having been returned to me by the Chief Electoral Officer pursuant to an order of the Supreme Court of Ontario, dated the 26th day of November, 1925, (2443-86-25) made under section 72, subsection 4 of the Dominion Elections Act: And the said Supreme Court of Ontario having, by order under the subsection aforesaid, commanded His Honour Judge E. N. Lewis, to comply with the provisions of the said Dominion Election Act on the subject of the recount of the votes; and in accordance with the said order His Honour Judge Lewis having, by his certificate dated December 23, 1925, declared that the number of votes lawfully given for each candidate was as follows, viz.: for John Warwick King, 5340 votes, and for George Spotton, 5170 votes;

"Therefore, in substitution for the return to the within writ made by me on the 19th day of November, 1925, I certify that the member elected for the electoral district of North Huron, as having received the majority of votes lawfully given is John W. King, of village of Bluevale, Ont.
