Pursuant to its Order of Reference of Thursday, November 7, 1974, your Committee has considered Bill C-18, An Act to amend the Fire Losses Replacement Account Act, and has agreed to report it without amendment.

A copy of the Minutes of Proceedings and Evidence relating to this Bill (Issue No. 8) is tabled.

Mr. Blais for Mr. Ethier, from the Standing Committee on National Resources and Public Works, presented the Second Report of the Committee, which is as follows:

#### Clause 4

Strike out line 8 on page 4 and substitute the following therefor:

"to the Commission under section 5, and to offer to hold at least one public hearing on the reference before establishing any boundary line for that part of the boundary that the problem or dispute is related to;"

Your Committee ordered a reprint of Bill S-13, as amended, for the use of the House of Commons at the report stage.

Mr. Reid, Parliamentary Secretary to the President of the Privy Council, presented,—Returns to the foregoing Orders.
