WHOLESALE VALUE OF MOTOR VEHICLE PRODUCTION

### Question No. 2,492-Mr. Hales:

- 1. What was the wholesale value of the 901,230 motor vehicle units produced in Canada in 1966, and the wholesale value of the 855,476 units produced in 1965?
- 2. What was the wholesale value of the 696,088 passenger cars produced in Canada in 1966 and the wholesale value of the 710,811 cars made in Canada in 1965?

Mr. Jean-Charles Cantin (Parliamentary Secretary to Minister of Trade and Commerce): 1 and 2. These figures were taken from the Dominion Bureau of Statistics' monthly report for December 1966 entitled "Preliminary Report on the Production of Motor Vehicles", catalogue number 42-001. These preliminary, production figures are compiled monthly but corresponding values are not collected.

Values of motor vehicles are collected annually in the form of shipments from plants. Final figures for 1966 will, therefore, not be available for some time since the motor vehicle manufacturers are only beginning to submit their reports for 1966.
