# PENITENTIARIES

PRINCE ALBERT—ESCAPE OF PRISONERS—REQUEST FOR COMMISSION

Mr. John Gilbert (Broadview): My question is also directed to the Solicitor General, Mr. Speaker. Has the minister anything to report on the escape of prisoners from Prince Albert Penitentiary, and would he consider setting up a commission to investigate the conditions and problems of inmates at that penitentiary?

Hon. G. J. McIlraith (Solicitor General): As to the Prince Albert escape, on November 25 we were advised that the 11 inmates of that institution had escaped.

Mr. Baldwin: On their way to the Liberal convention.

Mr. McIlraith: Four are still at large, two having been returned to prison yesterday and the five having been recaptured almost immediately after the escape. As to setting up an inquiry, there is a board of inquiry within the penitentiary service already looking into the matter and until this inquiry has been completed I cannot deal with the question as to whether any further type of inquiry is warranted.

The government, however, is doing whatever it can to have this organization stay in Montreal, under terms which take into account the interests of the government and those of ICAO.
