# LOCAL INITIATIVES PROGRAM—REQUIREMENT THAT APPLICANTS BE CANADIAN OR LANDED IMMIGRANTS

**Mr. W. B. Nesbitt (Oxford):** Mr. Speaker, yesterday I put a question to the Minister of Labour regarding eligibility for LIP grants. The minister replied that he was not sure of the answer but would look into the matter. The question was whether non-Canadian citizens who did not become landed immigrants would be eligible for grants. Is the minister in a position to give an answer today?

Hon. Martin P. O'Connell (Minister of Labour): Mr. Speaker, two circumstances prevail. In the case of sponsors, the requirement is that if they are receiving remuneration they must conform with the laws of Canada. That is spelled out. They must be either citizens, landed immigrants or if neither of those, they must have work permits. The same would apply for persons employed on a project. They must be citizens or landed immigrants or have work permits. The question of citizenship is not directly asked. The requirement is that all employees be paid and sponsors conform to all the laws of the competent authority, and that includes the labour laws.

**Mr. Speaker:** I shall allow the hon. member's supplementary but I think I should draw to the attention of hon. members that I shall attempt to recognize some of those who were not recognized yesterday. I think they can identify themselves or perhaps go back to *Hansard* and see whether or not they were reported yesterday. I shall make the effort today to recognize some of those who were not given the opportunity to ask questions yesterday. For the moment, the hon. member for Oxford may ask a supplementary.

**Mr. W. B.
