Hon. Jean-Eudes Dubé (Minister of Public Works): 1. (a) to (e) Approximately 3,000 letters and requests for Red Ensigns, were received during the past year by the Department of Public Works. Included among these were requests from Members of the House of Commons, of the Canadian Senate and of the Privy Council; as well there were requests from teachers and many others. A decision was taken that, in general, distribution would only be made in response to the requests made by, and on behalf of, recognized Veterans' organizations such as the Royal Canadian Legion and other officials institutions or associations. In addition requests from individuals deserving of special consideration were granted, such as Silver Cross Mothers, war amputees and others with disability pensions resulting from war service.
