- 4. How many persons or organizations have offered assistance to this project and what is the nature of their offers?

Hon. James Hugh Faulkner (Minister of Indian Affairs and Northern Development): 1 and 2. The exhibit is still at a preliminary stage of development. Costs have not yet been determined, nor have tenders been called.

- 3. It is hoped that interested historical societies, New Brunswick government resource persons, the Memramcook Institute and University of Moncton and any private individuals who so wish, will contribute to this project. Their contribution will provide Parks Canada with the necessary historical information relating to the Acadian story, and may assist in the locating of appropriate artifacts for the exhibit. At this early stage, the form which these anticipated contributions will take cannot be identified with any greater precision.
- 4. To date, the Memramcook Institute and officials of the University of Moncton have offered assistance in identifying potential sources for historical information. Further contacts will be made with interested agencies and individuals as work progresses.
