I am greatly impressed by the outstanding names of the promoters, as given in the preamble of the bill. They are men of great ability, experience and substance. No doubt can exist as to their ability to make a success of a new bank. I have the utmost respect and confidence in them in that regard. With a little more time I shall be able to express a more considered opinion on the question of expediency: should we or should we not wait until the report of the royal commission is received and the Bank Act is submitted to us for decennial revision? I think it is wise for us to consider that aspect before creating a precedent which might prove embarrassing when other applications are received.

Honourable senators, I move, seconded by the honourable Senator Croll, the adjournment of this debate until Wednesday next,

March 11.

On motion of Hon. Mr. Vien, debate adjourned.
