*Graham, Hon. Geo. P.* (Minister of Railways and Canals)—8552.

There was some question as to the rates to be charged—8552. It was suggested that we leave till Mr. Porter was here—8553. Whatever error was made, was in the introduction of this legislation into this House—8558. It struck me that it ought not to be legislated on here—9066. Whether the province would not take exception to our legislating about such an agreement—9067.

*Porter, E. Gus* (East Hastings)—9066.

Supposes *Graham* refers to the agreement between the city of Belleville and the company—9066. If Bill were withdrawn would still have legislation by this parliament—9067. Everybody is satisfied, and so far as bicycles are concerned it will not hurt anybody—9068.

*Pugsley, Hon. Wm.* (Minister of Public Works)—8557.

This company should have been incorporated by the provincial legislature—8557. No right to assume by our Act that we have jurisdiction—8558. That is under the express terms of the B.N.A. Act—8559.

*Reid, J. D.* (Grenville)—8553.

The insertion of the words 'Lieutenant Governor' would overcome the objection—8553. It would carry out what he is trying to state the Bill should be—8554.

*Sproule, T. S.* (East Grey)—8552.

The member in charge of the Bill is not here—8552. The federal parliament the only authority that controls the crossing of navigable water—8555. Streams that were not navigable under provincial control—8556. The proper authority to deal with it is the Railway Commission—8557. Better let it stand till the member in charge is present—8558. Only the federal parliament has power to give that right—8559.
