

against the said companies, rights, privileges, and powers of the holders of the respective bonds were entitled, by virtue of the securities or of the said mortgage deed of trust, prior to payment of the bonds by the province under its guarantee with respect to the securities, to be in the same position as the holders of the securities upon which the company has made default.
