

1st. *Resolved*, As the opinion of this Committee, That so much of His Excellency's Speech as relate to the encouragement of Agriculture should be referred to the Committee appointed to take into consideration the subject of the Agricultural Interests of the Province.

2d. *Resolved*, As the opinion of this Committee, That such parts of His Excellency's Speech as relates to the settlement of the Crown Lands, and the management of the Indian Reserves, should be referred to a Select Committee to report thereon by Bill or otherwise.

3d. *Resolved*, As the opinion of this Committee, That so much of His Excellency's Speech as relates to the encouragement of Domestic Manufactures should be referred to a Select Committee to report thereon by Bill or otherwise.

4th. *Resolved*, As the opinion of this Committee, That that part of His Excellency's Speech relating to the Fisheries should be referred to the Committee appointed to take into consideration all matters connected with the Fisheries.

5th. *Resolved*, As the opinion of this Committee, That the Paragraph of His Excellency's Speech relating to Education should be referred to a Select Committee to report thereon by Bill or otherwise.

6th. *Resolved*, As the opinion of this Committee, That the Paragraph of His Excellency's Speech relating to the Provincial Prisons should be referred to a Select Committee to report thereon by Bill or otherwise.

7th. *Resolved*, As the opinion of this Committee, That the Paragraph of His Excellency's Speech relating to the Laws in force for the regulation of Savings' Banks should be referred to a Select Committee to report thereon by Bill or otherwise.

8th. *Resolved*, As the opinion of this Committee, That that part of His Excellency's Speech relating to Internal Communication should be referred to the Committee for taking into consideration the state of the Roads of Communication in the Province.
