My dear Prime Minister:

Thank you for your recent letter confirming the January 10 date for the dominion-provincial conference to consider a method of amending the constitution of Canada. It is felt here that different techniques may be required for different matters. If this be so, it would be difficult to consider the question of amendment in a general way. I would therefore be very much obliged if you could send me the proposed agenda. I am certain you will understand the difficulty with which we are faced in trying to do preparatory work before knowing what items are coming up for discussion and what the method of procedure will be. I note, too, that a preliminary meeting of constitutional experts, in advance of the main conference, is not to be held. This fact necessitates our having a proposed agenda as soon as possible.

My dear Mr. Prime Minister:

I have your letter of the 7th instant.

My feeling is that the reduction of the subject matter of the conference opening January 10 to an agenda of procedure is not necessary. I think better progress will be made if the question of procedure in the conference is left until the conference itself convenes. These matters can then be considered and settled. If in the meantime any of the other provinces have suggestions to make in this regard, I should be glad indeed if you would advise me. My feeling at the moment is that a formal agenda is not necessary.

Concerning your proposal that a general provincial conference should be held early in the autumn of 1950, possibly in September or October, I am in agreement. In this case the situation is quite different and there are many matters which the various provinces will probably be anxious to have discussed. In this case an agenda of subject matters should be prepared in advance, although I believe as much of the procedure as possible should be left to the conference itself. I shall be glad to discuss this matter with you at any time.
