

*Bank Act***GOVERNMENT ORDERS***[Translation]***BANKS AND BANKING LAW REVISION ACT, 1980**

MEASURE RESPECTING BANKING INSTITUTIONS

The House resumed, from Friday, November 14, consideration of Bill C-6, to revise the Bank Act, to amend the Quebec Savings Banks Act and the Bank of Canada act, to establish the Canadian Payments Association and to amend other acts in consequence thereof, as reported (with amendments) from the Standing Committee on Finance, Trade and Economic Affairs.

Hon. Pierre Bussières (Minister of State (Finance)) moved:

Motion No. 27

That Bill C-6, an act to revise the Bank Act, to amend the Quebec Savings Banks Act and the Bank of Canada Act, to establish the Canadian Payments Association and to amend other acts in consequence thereof, be amended in clause 2

(a) by striking out lines 46 to 48 at page 209 and substituting the following therefor:

"motor vehicle having a gross vehicle"

(b) by striking out line 2 at page 211 and substituting the following therefor:

"are situated;

"motor vehicle" means a motorized vehicle designed to be used primarily on a public highway for the transportation of persons or things but does not include

(a) any fire engine, bus, ambulance or utility truck, or

(b) any other special purpose motorized vehicle

that contains significant special features that make it suitable for a specific purpose and that is manufactured by a person other than the vehicle manufacturer who manufactured the basic chassis;"

Madam Speaker: Is it the pleasure of the House to adopt the said motion?

Some hon. Members: Agreed.

Motion agreed to.

Hon. Stanley Knowles (for Mr. Rae) moved:

Motion No. 28

That Bill C-6, an act to revise the Bank Act, to amend the Quebec Savings Banks Act and the Bank of Canada Act, to establish the Canadian Payments Association and to amend other acts in consequence thereof, be amended in clause 2 by striking out lines 14 to 17 at page 221 and substituting the following therefor:

Mr. Ray Skelly (Comox-Powell River): Madam Speaker, it is my understanding that we are dealing now with motions Nos. 24 and 26.

Madam Speaker: We are dealing with motion No. 28.

Mr. Skelly: Madam Speaker, as a point of information, before beginning my discussion may I ask what the disposition of motions Nos. 24 and 26 was?

Madam Speaker: Motions Nos. 24 and 26 could be grouped for debate. At any rate, they have not been dealt with yet. Exactly what will be done with motions Nos. 24 and 26 has not been announced in the House.

Mr. Don Blenkarn (Mississauga South): Madam Speaker, on Thursday there was a House order which said that motions Nos. 24 and 26 would be grouped for debate and that an affirmative vote on motion No. 24 would necessitate a question being put on motion No. 26. Indeed, all of the amendments right through to motion No. 58 were dealt with by House order.

Madam Speaker: I think I can now enlighten the hon. member. There was an order of the House concerning these motions. Motions Nos. 24 and 26 could be grouped for debate, and a negative vote on motion No. 24 will dispose of motion No. 26. An affirmative vote on motion No. 24 will necessitate a question being put on motion No. 26. However, before dealing with that we must deal today with motion No. 28.

Mr. Blenkarn: Thank you, Madam Speaker. I agree that we should proceed with motion No. 28 right through to motion No. 58 in accordance with the House order of November 13, and follow through with motions Nos. 24, 26, 29, 31, 32, 33, 34, 35 and so forth as that House order directed.
