I have been a member of Parliament for the past 15 years, and the remarks I have heard today remind me of the times-I think you were sitting on the Standing Committee on Agriculture then, Mr. Speaker-when we had to deal with the legislation establishing farm product marketing agencies. We hear again today the same whining we heard then while trying to set up farm product marketing agencies and to make sure farmers had stable incomes more in line with their production costs. The Tories' moaning is exactly the same as before, as you can ascertain from reading the official record of the times. Even after 13 years, they are raising the same issues.

MUNICIPAL GRANTS ACT, 1980

OPPORTUNITY TO REASSESS EXCEPTIONS AND TO AMEND LEGISLATION

Mr. Gaston Gourde (Lévis): Madam Speaker, I should like to draw the attention of the House on a Bill passed in the early days of the session. I refer to Bill C-4 respecting grants to municipalities in lieu of taxes. Since 1980, the Government of Canada has been discharging its obligations as a taxpayer like all other citizens in Quebec. However, there are some exceptions to that legislation which, in my opinion, should be changed. Indeed, not subjected to that legislation and thus excluded from the accounts for the grant purposes are some fixed assets such as jetties, breakwaters and drydocks. Recently, the City of Lauzon has advised me that the exclusion of drydocks alone was reducing the cash taxable value by \$20 million and that the Government of Canada was establishing its grants on a basis of \$2 million instead of \$22 million. We think, Madam Speaker, that this real property should not be excluded and that the legislation should be amended accordingly. I tabled a Notice of Motion asking the Government to consider the opportunity of amending the legislation in order to satisfy several municipalities. We should also take that opportunity to reassess all the exclusions to the legislation and consult the organizations involved such as the Union des municipalités.
