### VIA RAIL SERVICES

## UNEMPLOYMENT INSURANCE ACT AMENDMENTS

Mr. Steve Butland (Sault Ste. Marie): Mr. Speaker, I rise hopefully to soften the hardened hearts of the Government. I am pleased to table a petition pursuant to Standing Order 36 on behalf of some great Canadians of Ontario. They, too, are protesting the proposed changes in the Unemployment Insurance Act which may, indeed, adversely affect one million Canadians.

Mr. Chris Axworthy (Saskatoon—Clark's Crossing): Mr. Speaker, it is my honour to present a petition dealing with changes in the Unemployment Insurance Act and signed by a number of Canadians from across the country.

They are protesting the taking of funds from those who are unemployed and directing those funds to retraining, rather than finding new sources of funds for retraining. They are also complaining about the fact that the Government did not mention this in its election platform and are concerned about the fact that it will take one million Canadian, annually, off the unemployment insurance lists, leaving them without any means of support other than at the behest of the provinces.
