

Exchange of Notes between Canada and the Union of South Africa, amending for the period September 1, 1946, to March 31, 1947, the Trade Agreement of August 20, 1932, as regards carpet wool imported into Canada. Signed at Pretoria, October 22, 1946. (Treaty Series, 1946, No. 39).

Exchange of Notes between Canada and the United States of America relating to the application and interpretation of the (Rush-Bagot) Agreement of 1817 concerning the naval forces on the Great Lakes. Signed at Washington, November 18 and December 5, 1946. (Treaty Series, 1946, No. 40).

Exchange of Notes between Canada and the United States of America, recording an Agreement for the waiver of claims arising from maritime collisions involving vessels of the two countries. Signed at Washington, September 28 and November 13-15, 1946. (Treaty Series, 1946, No. 42).
