## PETITION AGAINST WOMAN CAUSE OF SLANDER SUIT

Residents of York County Defendants in Action for \$10,000—The Evidence.

Mrs. Isabella Pherrill of Woburn, York County, asked the jury in the assize court yesterday to grant her \$10,000 damages against John Sewell and William Jones, farmers of Markham Township, for alleged slander contained in a petition circulated around Markham and Box Grove in November, 1906, asking the township council to take steps to have the family removed from the house of the late W. Stoner in Box Grove. Mrs. Pherrill occupied the house at the time. The defendants denied malice in circulating the petition and at the same time claimed justification on the grounds that the woman was of reproachable character.

The jury handed in a sealed verdict which will be announced at this morning's sitting.

Several witnesses who signed the petition were all given a reverse cross-examination by J. M. Godfrey, who appeared for the plaintiff, on their gossiping tactics, and when the latter was giving his address to the jury, in which he referred to the witnesses "as the dear good people of Box Grove," he asked the Box Grove contingent to leave.

Mrs. Pherrill during her evidence broke down and cried and was excused from further attendance by Justice Mabey. She said she kept Stoner's house for years after his death, it having been left to her by Stoner, if she would look after his four children. Cross-examined by Mr. McCullough for the defence, she admitted that she had two men at her house at various times of the year and had been a boarder for some time.

"Has that husband of yours done anything for your children since he left four years ago?" asked Mr. Godfrey in re-examination.

"Nothing," answered Mrs. Pherrill in a whisper.

"And why did you drop the suit for alimony against him?"

"Because I could get nothing out of him."

"And did those good ladies of Box Grove, those who belong to the Ladies Aid Society, ever visit you?"

Here Mrs. Pherrill broke down and began to sob violently. A chair was put into the witness stand and seating herself Mrs. Pherrill turned her face to her arms and cried.

William Jones swore he had never said that the house was used for immoral purposes. He considered Mrs. Pherrill was doing wrong when she sold the fruit which grew on the lot.

## EAST TORONTO

Local Curriers Down the Malvern Cracks—Don't Favor Raise.

EAST TORONTO, Feb. 4.—Fred Blouw, a G. T. R. brakeman, living on Norwood-road in this village, met with an accident shortly before 7 o'clock this morning, which later in the day caused his death.

Blouw was working on a freight running between York and Belleville, and it was while the train was between Scarborough and York, and just before entering the village, that the unfortunate man, presumably in running along the footboard on the top of the car, by some means lost his footing and fell to the ground, fracturing his skull.
