Issue Certificates Expressing Appreciation of King of Soldiers "Mentioned in Despatches."

Ottawa, Feb. 20.-(By Canadian Press) .- Certificates expressing the thanks of his majesty to those of. ficers and men of the Canadian expeditionary force who were "mentioned in despatches." have been received and are now being distributed by the militia department. The first instalment of these' certificates received from the war office numbers 1,200, but the total number will be in the neighborhood of 5.400. The certhe neighborhood of 5.400. The cer-tificates, which bear the signature of Winston Churchill. British secretary of state fok war. are headed, "The War of 1914-'18." They state that the sol-dier specified has been mentioned in a despatch from Field Marshal Sir Douglas Haig for gallant and distin-guished services in the field, and that his majesty has commanded that his high appreciation of these services be recorded. lecorded

PETITION FOR POWER TO RAISE SUGAR PRICE

Montreal, Feb. 20 .- A petition to be allowed to increase the price of sugar by two cents a pound, bringing the cost to the retailer to eighteen cents a pound, was made on the board of nmerce this morning by the refining companies.

Judge Robson of the board of com merce promised that a decision would be handed down at an early date. He remarked that Canada had been very fortunate in regard to sugar during the past five weeks, and had been one of the cheapest countries in the world in this respect.

In adjourning the hearing Judge Robson said that he knew the public would raise a protest at any increase in the price of sugar, but hoped the public would keep itself informed thru the press reports of the board's meetings what causes were operating to make price increases compulsory.

COBALT SILVER SHIPMENTS.

Cobalt, Feb. 20 .- Both ore and bullion shipments from the Cobalt camp were light in the week ending tonight. In the former the official T. and N O. statement shows only two cars, and ten bars of bullion sent out by the Dominion Reduction Co. constitute the sole bullion consignment. The details are—Ore: Coniagas, one car, 66,070 pounds; La Rose, a frequent shipper of late, one car, 84,952 pounds; total, two cars, 151,022 pounds.
