The Honorable Sir *E. P. Taché*, from the said Committee, reported an Address prepared by them as follows:

To the Queen's Most Excellent Majesty.

MOST GRACIOUS SOVEREIGN:

We, Your Majesty's most dutiful and loyal subjects, the Legislative Council of *Canada*, in Provincial Parliament assembled, humbly approach Your Majesty for the purpose of praying that Your Majesty may be graciously pleased to cause a measure to be submitted to the Imperial Parliament for the purpose of uniting the Colonies of *Canada, Nova Scotia, New Brunswick, Newfoundland, and Prince Edward Island*, in one Government, with provisions based on the following Resolutions which were adopted at a Conference of Delegates from the said Colonies, held at the City of *Quebec*, on the tenth of October, 1864, that is to say:—
