Two Charges of Corruption in the London Election Trial.

The Judges Say the Case Is Clearly Made Out.

That Thomas Haynes Was Given Money and Promised Work

Cast His Vote To for Mr. Beattie.

Other Charges

Sensational Testimony by Arthur Ray, James Murphy and Pat Quigley,

Who Claim They Each Received \$5 From Aid. Carrothers.

John Sullivan Says Mr. Toothe Gave Him \$4,

And Got Him to Organize a Drum Corps - An Afternoon Session Full of Interesting Developments -Excitement in Court.

Wednesday Afternoon. Following is the continuation of yesterday afternoon's evidence in the London election trial:

THOMAS HAYNES. Thomas Haynes, husband of the previous witness, said he voted at the last election. He did not know Boyd till the week before the election He saw him on the Monday night, the week before the election. His wife had previously given him a card with Mr. Boyd's address. Boyd asked witness how he voted. Witness said he had always voted Reform. Boyd asked him to support Beattie. Witness replied he would see. Boyd said he had some work to be done, and asked witness

if he wanted to do it. TO MOW HIS LAWN.

Q-What did he say the work was? -To mow his lawn. (Laughter.) Q.-What else did he say? A .- He said he would have other work for me at White's boiler works. Q.-What about the lawn? A .- I went to Mr. Boyd's next morning at Pigot & Bryan's.

Q.-What was said? A .- He said it was too wet to cut the lawn that morning. He said "remember Mr. Beattle," and I walked away.

A .- To the nominations. Q.—How did you come to go there? A.—By the request of Mr. Boyd. He asked me if I had ever met Mr. Beattie. I said no. He asked me to go to mination, and I went. Q.-When did you see Mr. Boyd

A .- Next day at the store. Q.-What took place? GAVE HIM TEN SHILLINGS. A .- He gave me ten shillings-\$1 25. It was rolled in an envelope. He put

### it in my hand and said: Don't forget Mr. Beattie. I said, what about the

had a talk with Boyd in the hall, and

Q.-Did you ever cut the lawn? Q .- Were you ever asked to?

Witness said Boyd had come to him subsequently while witness was at a prayer meeting and told him he (Boyd) had got into trouble over the money. Boyd wanted witness to make a full statement. Witness said he would not do so that night.

To Mr. Helmuth witness said he was at a prayer meeting at a private house when Boyd called. It was about two weeks ago. Witness said he would not sell his vote, and never did sell The \$1 25 and ten cents that Mr. Boyd gave him was not the price of his vote. Witness did not tell Mr. Boyd that the French and Catholics were getting everything, and that he (witness) was not going to vote Grit. Q.-Didn't he discuss the political questions of the day?

A.-No. It was all about Beattie. (Laughter.) Q.-Didn't you tell him that your wife was ill, and that you thought of sending for her mother, but that you

had not the means? A.—No. I said no such thing. Witness said Mr. Boyd had told him once that the lawn mower was being repaired. He told Mr. Boyd the night before the election that he would not act as constable, and witness thought the \$1 25 was for the purchase of his vote when he opened the envelope.

Q.-Why? A .- Because it was too much money by half for the work of mowing the Mr. McKillop-How long would it take to cut Mr. Boyd's lawn?

A .- Three hours BOYD AN AGENT Mr. Osler put in Mr. John R. Min-

HERPERT J. BOYD. Herbe J. Boyd, sworn, said he was a bookkeeper in Pigot & Bryan's. Witness was on a Beattle ommittee in No. 6 Division. It was through Richard Galpin that witness came to call on Haynes. Witness said he went to Haynes' house at the time Mrs. Haymes' Haynes spoke of, and Haynes was not at home. Witness left his card. The next day Haynes called at the store. Haynes said he had always voted Liberal, but this time he was going to vote Conservative, because he had been out of work a long time, and any Liberals whom he asked for work had given it to Roman Catholics. Haynes wanted to know if there was anything

he could get to do in the store. Witness said no, and nothing further occurred that day. Witness said Haynes came into the store next day and said he was very hard up. Witness said he would try to give him a day's work at his (Boyd's) house, cutting the grass and oleaming up the place.

Witness next saw Haynes at his (Haynes') house. Witness went to see if Havnes would act as constable on election day. Witness told Haynes to go and see Mr. Galpin for that pur Witness told Haynes he had heard of a job as ponter at White's at \$1 day. Haynes said he would be

willing to take anything. and said Mrs. Hayn's was suffering a day or two. Witness said his lawn mower was being fixed and would be ready in a day or two. Haynes again came to see witness and said he wanted to send for his mother-in-law. He asked witness to advance him the money for cutting the grass, promising to do the work when the mower was fixed. Thereupon witness gave Haynes \$1.25, in an envelope, which witness had previously left with the cashier, Haynes returned to ask if the mower was repaired. Witness said it was,

got it back? A.—Yes.
