EXTENSION OF LEGISLATION TO COVER PROFESSIONAL SPORTS

operations of the National Hockey League to be outside the purview of the Combines Investigation Act, and in light of the size and scope of the operations of this organization and the interest of the people of Canada in it: and having in mind the obvious restrictive effects of present arrangements as to the extension of franchises and other related matters, will the government give immediate consideration to amending the act so as to bring such operations within its scope in the interests of the people of Canada?

Hon. Guy Favreau (President of the Privy Council): Mr. Speaker, the hon. gentleman will remember the remarks he made before a parliamentary committee in relation to the fact that services are not presently covered by the Combines Investigation Act. However, I am pleased to advise him-and I do not want to refer to the National Hockey League or any other specific organization—that in relation to any service, the question as to whether and to what extent services may be included within the ambit of the act is presently under consideration.

Mr. Fulton: I have a supplementary question. Whatever may have been said in the past does not seem to me to apply now; but in respect of the question as to whether services were exempted—and I am not entering into an argument on that situation—surely the minister does not feel we have to go into the whole matter of whether a sport in this sense is a service. Does the minister not rather feel-
