INDIAN AFFAIRS

MEETING BETWEEN MINISTER AND INDIAN REPRESENTATIVES

Mr. Frank Howard (Skeena): My question is directed to the Minister of Indian Affairs and Northern Development. May I ask the minister whether he will reconsider his decision of yesterday, which I understand was that he would not meet a delegation of four persons relating to certain matters concerning Indian people in Alberta. Would he arrange to meet the gentlemen in question, to hear their complaints?

Mr. Speaker: Order, please. This question is a bit mysterious, and is couched in general terms making it impossible for the Chair at this time to decide if it is of national importance and great urgency. I suggest to the hon. member, if it is of great urgency, that he discuss it at the adjournment debate this evening.

Mr. Howard: The question is so urgent that it cannot wait until ten o'clock this evening. An arrangement was made yesterday for a group of native Indians to meet with the minister at 1:45. For some reason unknown to me the minister was not able to meet these men, or failed or refused to meet them. I ask him now to reconsider his decision, because the lives of a number of native Indians in Alberta hinge on this meeting.
