POLLUTION CONTROL IN INTERPROVINCIAL WATERS—AIR POLLUTION

My question concerns the question of federal responsibility for pollution matters. It arises from the fact the responsibility seems to be fragmenting now, rather than becoming effective. I ask the Prime Minister to lend his mind to this subject and make a statement shortly. The Water Conservation Act is not the answer to the over-all problem.

Mr. Speaker: I have to agree with the hon. member. His question sounds very much like the one he asked earlier today.

Mr. Aiken: I did not get an answer to the previous question. I think the Prime Minister is ready to answer this one.

PLACENTIA BAY, NFLD.—COMPENSATION TO FISHERMEN FOR LOSS THROUGH POLLUTION

Mr. James A. McGrath (St. John's East): Mr. Speaker, in the absence of the Minister of Fisheries and Forestry, and the Acting Minister of Fisheries and Forestry, and the Minister of Transport, who has a great deal of interest in this matter, I would like to direct my question to the energetic and ambitious Parliamentary Secretary to the Minister of Fisheries and Forestry. Is he prepared to tell the house what the Minister of Transport meant when he said at St. John's the other day that

the government would be coming up with a revised plan of compensation for the fishermen of Placentia Bay—

Mr. Speaker: Order. The hon. member's question is not in order. He cannot ask the Parliamentary Secretary to give an interpretation of the statement made by the minister.

Mr. McGrath: Then, Mr. Speaker, would you permit me to rephrase my question and ask the parliamentary assistant what is the revised plan of assistance that the government has devised for the fishermen of Placentia Bay?

Mr. E. F. Whelan (Parliamentary Secretary to Minister of Fisheries and Forestry): Mr. Speaker, I do not know what the hon. member has in mind at all times, but I can tell him that we have set up an appeal board with three trustworthy and honest fishermen on it, together with two trustworthy and honest civil servants, to listen to the appeals of fishermen in cases where they do not feel they are being properly compensated. I think this is the answer.
