### UNITED STATES SUPREME COURT DECISION ELIMINATING NEED FOR JURY UNANIMITY IN CRIMINAL CASES—CANADIAN POSITION

**Mr. Derek Blackburn (Brant):** Mr. Speaker, my question is for the Minister of Justice. In light of a recent decision by the United States Supreme Court eliminating the need for unanimity among juries in criminal cases, does the minister intend to introduce similar legislation applicable to Canada?

Hon. Otto E. Lang (Minister of Justice): We have no immediate intention of introducing such legislation. The whole question of the appropriate approach to criminal law reform is being studied presently by the Law Reform Commission as well as in the department and may result in legislation at the next session.

TEXTILES—ORDERS SENT TO ROUMANIA—MEASURES TO PROTECT JOBS OF CANADIANS

**Mr. André Fortin (Lotbinière):** Mr. Speaker, my question will be of interest, I hope, to the Minister of Industry, Trade and Commerce.

Some Canadian textile industries enjoying financial support from the federal government now order almost as much work in Roumania as in Canada, thus jeopardizing the jobs of Canadian workers. Is the minister aware of this fact and does he intend to take specific measures to preserve Canadian jobs in the textile field?

Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): Mr. Speaker, I have—

**Mr. Speaker:** Order. I hope the minister will be able to reply briefly to this question. I am sure the hon. member for Lotbinière will admit that his question has a very wide scope and should normally be answered by the minister in the form of a statement on motions. **Mr. Pepin:** Mr. Speaker, I can only confirm that indeed we import textiles from Roumania. If we wish to continue to export our products to Roumania, I suggest that we have to allow Roumania also to export her products to Canada.
