promised permit regulations, thus allowing essential oil and gas exploration to continue?

Hon. Donald S. Macdonald (Minister of Energy, Mines and Resources): Mr. Speaker, perhaps I could answer on behalf of my colleague, who is responsible for the regulation system north of the sixtieth parallel, and for myself as I am responsible for the offshore situation. As the hon. gentleman knows, there have been extensive discussions with the provincial governments with respect, among other things, to royalties to be established for the exploitation of continental shelf resources. This is one of the issues in which the provinces are most interested. We think this discussion should be brought to a successful conclusion before we make any further decision with respect to the royalties.

Mr. Bawden: May I ask the minister whether, in view of the fact it is now three years since this delay was first instigated, he is now prepared to issue regulations covering lands in the northern part of Canada which are clearly within his jurisdiction?

Mr. Macdonald (Rosedale): It is interesting to note that the hon. gentleman refers to provincial consultation as delay. It seems to me that the federal pattern of economic rent should be a consistent one and that we should await the result of these consultations before announcing an over-all policy.
