GOVERNMENT POSITION ON WORLD FOOTBALL LEAGUE— ACTION TO PROTECT CANADIAN FOOTBALL LEAGUE

Mr. Otto Jelinek (High Park-Humber Valley): Mr. Speaker, my question is for the Minister of National Health and Welfare. As the CFL seems to be turning its back on the minister, who even acted as father protector of the league, by not following up on its expansion program and by suggesting its willingness to consider a merger with the WFL, is the minister prepared to reconsider the stand he took on Bill C-22 in the last parliament, in view of actions the WFL may once again take to play in Canadian cities or, indeed, to merge with the CFL.

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, this is a subject on which the House expressed itself last year. The House voted on it, although the bill was not passed finally. Before introducing the same bill, a similar bill or a different bill, I will have to discuss the matter with my colleagues and members of my party.

Mr. Jelinek: A supplementary question, Mr. Speaker. Owing to the continuing deterioration in the quality of CFL teams and the resulting 6 per cent decline in attendance last season, partly as a result of WFL raiding, that league not being allowed to play in Toronto—

Some hon. Members: Oh, oh!

Mr. Jelinek: —will the minister, as a concerned guardian of Canadian football, advise the House of the steps he intends to take to protect the CFL from further deterioration and prevent the possible phasing out of the Canadian Football League.

Mr. Lalonde: Mr. Speaker, obviously, such steps would be announced in due course.

promoting the status of women in Canada, and as, during World War II, women pilots ferried aircraft from Canada to England, will the minister explain why now, in a period of relative peace, at least in Canada, women are denied the right by the Department of National Defence to join the Canadian Armed Forces and take pilot training.

Mr. Leonard Hopkins (Parliamentary Secretary to the Minister of National Defence): Mr. Speaker, as the hon. member knows, the girls are now going to be allowed to join the cadet corps. However, I will take his original question as notice.

Mr. Brisco: A supplementary question, Mr. Speaker. With all due respect to the Parliamentary Secretary to the Minister of National Defence, this member does not know about girls taking pilot training. I would ask the minister or the parliamentary secretary when this became policy?

Mr. Hopkins: With all due respect to the hon. member, I think he misunderstood my remarks. I meant that in the bill presently before parliament, girls are to be officially recognized in the cadet corps.

Mr. Knowles (Winnipeg North Centre): Mr. Speaker, I rise on a point of order. When the Prime Minister put a question to me concerning the letter from Mrs. Valentyn Moroz to which I had referred, I said it was a letter addressed to four world leaders. On checking my notes, I see that it was addressed to only three world leaders, namely, to the President of the United States, the Chancellor of West Germany and the Prime Minister of Canada.
