Miss MacDonald (Kingston and the Islands): Mr. Speaker, is the minister aware that his colleague's statement is not in accord with the legislation regarding maternity benefits proposed in Bill C-16, and given the confusion that this has caused among the general public and the UIC offices across the country about the intent of the amendment, will the minister move toward resolving this situation by arranging with the House leader to have this bill brought forward immediately?

FREIGHT RATES—APPLICATION FOR 20 PER CENT INCREASE— POSSIBILITY OF INTERVENTION BY MINISTER TO PREVENT

Mr. Jack Murta (Lisgar): Mr. Speaker, I should like to direct my question to the Minister of Transport. On February 24, 1975, in a joint communiqué of the meeting of federal and provincial ministers of transport on western transportation the minister was quoted as saying that he was opposed to any further general horizontal percentage increases in freight rates. Noting that The Canadian National Railways have filed for a 20 per cent increase in class of freight rates which would come into effect on May 5 and which could have quite a spin-off effect on other rates, I should like to ask the minister what action he will be taking in support of his statement that he is opposed to any further horizontal rail freight rate increases?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, yesterday I had exactly the same question put to me. Today the answer is the same. I am still opposed to the kind of increase that is proposed.

Mr. Murta: Since the purpose of the 18 month freeze on freight rates was to find a solution to the so called anomalies and noting that the final study has not been completed as yet, and since the minister says he is still opposed to a further increase, but a decision will have to be made one way or the other before May 5 when the increases will come into effect, what specific action will he take? Rather than telling us his views, can he tell us what his department will do?

Mr. Marchand (Langelier): I think that I spoke about ten times in the House on how the freeze was imposed, for what purpose and for what length of time. All these questions were answered and I have nothing new to add.
