INDIAN AFFAIRS

POLICE RAIDS ON RESTIGOUCHE RESERVE IN QUEBEC—MOTION UNDER S.O. 43

Mr. Jim Fulton (Skeena): Madam Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. Last week the Micmac Restigouche reserve in Quebec was raided by the Quebec Provincial Police. The raid was a blunt attempt to keep the Indian people from fishing. Today the reserve is again facing possible raids, as the police have once more surrounded the reserve.

The executive of the National Indian Brotherhood has gone to Restigouche in support of the Micmac people and to attempt to avoid any violence which might be sparked by another raid. As the Fisheries Act is a federal statute and the responsibility for Indian rights and lands is in the jurisdiction of the federal government, I move, seconded by the hon. member for Nunatsiaq (Mr. Ittinuar):

That this House condemns the Restigouche raids and demands a full inquiry into the role of the federal government to protect the Micmac people.
