BARRIE HOSPITAL FUND RAISING CAMPAIGN—REFUSAL OF TAX DEDUCTIBILITY

Mr. Ron Stewart (Simcoe South): Mr. Speaker, my question is directed to the Minister of National Revenue. The Minister will be aware that one of his officials, Mr. Robert Young, has interfered with the fund raising efforts of the Royal Victoria Hospital in Barrie. The hospital plans to give one autographed copy of a print by Ken Danby, a well known Canadian artist, to each of 500 persons who donate in excess of \$500 to the building fund of the Hospital, which would bring in the amount of \$250,000.

Mr. Young has ruled that, if this is done, tax deductible receipts will not be issued. In light of the fact that his Department will collect tax on the \$20,000 which Mr. Danby will receive for the original painting, and the fact that I have previously brought this up in the House and have written the Minister two letters, will the Minister now agree to reverse Mr. Young's decision and support this very worth-while cause?

HOUSING

FUNDING OF CO-OPERATIVE AND NON-PROFIT GROUPS

Mr. Stan J. Hovdebo (Prince Albert): Mr. Speaker, I have been waiting for three days to ask a question of the Minister responsible for housing. I will ask it of the Prime Minister.

In the past, Mr. Speaker, the unit allocation for co-ops and non-profit housing was in the hands of the recipients by the end of February in order that work could start on the projects. We are well into May and the co-ops and non-profit housing groups are still waiting for an indication of the total number of units which will be approved this year. CMHC is stalling, and releasing funds in dribs and drabs. Can the Prime Minister tell us why the money has not been sent out to these groups? How many units are going to be approved? Would it be possible to have that amount tabled in the House?
