These are people in the private sector who are supposed to meet and determine the scope of rationalization.

REQUEST FOR CLARIFICATION OF POSSIBILITY OF CLOSING SOREL SHIPYARD AND LEAVING YARDS AT LAUZON AND MONTREAL OPEN

Mr. Jean-Claude Malépart (Montreal—Sainte-Marie): Mr. Speaker, is the Minister aware of the fact that Mr. Saunders is responsible for two shipyards in Quebec, one in Lauzon and one in Montreal, and that Quebec is responsible for the shipyard in Sorel? Does the Minister want us to believe that Mr. Saunders is capable of closing down the Sorel shipyard and leaving the other two yards open?

Hon. André Bissonnette (Minister of State (Small Businesses)): Mr. Speaker, see what it's like, when someone will not listen!

We are talking about someone involved in the industry, and the fact that these people have to talk to each other. If they don't, how can you expect them to come up with something positive? Mr. Saunders has two shipyards. I imagine he should be able to talk with the other yard owners about what the best policy will be.

ALTERNATE DAY DELIVERY PROPOSAL

We are examining many alternatives, and one of them could be alternate-day service.

Mr. Cyril Keeper (Winnipeg North Centre): Mr. Speaker, the Minister has just admitted that he is examining alternateday service. Will he bring that report forward and make it public so that the examination of the alternatives can be made in a public environment?

Hon. Michel Côté (Minister of Consumer and Corporate Affairs and Canada Post): Mr. Speaker, this is one of the alternatives that we are examining. As soon as we will make a decision on that, we will make it public.
