In part it states that the Government of Canada has introduced changes that will reduce homekeeping services to veterans and substantially increase the cost of long-term care. Whereas the veterans have already given service to this country and should not be targeted by those measures, the petitioners call upon Parliament to reject those budget measures which deprive veterans of proper services and increase their financial hardships.

The Minister of Veterans Affairs has made some movement away from this very draconian position, but he has not gone far enough. The petitioners believe this is grossly unfair to the country.

VETERANS' BENEFITS

UNEMPLOYMENT INSURANCE

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Madam Speaker, I want to table a petition today pursuant to Standing Order 36. This petition follows closely a vote by this government when it refused to recognize the importance of unemployment insurance to eastern Canadians and, in particular, turns down the variable entrance requirements that were proposed in that bill. We regret the position of the government. These people petition the House of Commons and Parliament that whereas the unemployment insurance system is vital to the well-being of Canadians in providing temporary income protection to unemployed Canadian workers; whereas the Government of Canada is proposing to drastically cut unemployment insurance benefits by making it more difficult to qualify and reducing the number of weeks covered; whereas the Government of Canada is withdrawing its contribution of \$2.9 billion to the unemployment insurance fund and leaving the financing to workers and employers, these people reject these cuts to the unemployment insurance system and propose more meaningful reforms that should concentrate on labour force development strategy combined with a full employment policy and effective regional development policies.
