Reported amended, 245. Considered in Committee of the Whole; progress reported, 310. Again considered in Committee; reported; motion for third reading; Amendment by Mr. McInnes relative to non-employment of Chinese; negated; Bill read third time; passed, 322. Passed by Senate with an amendment, 496. Agreed to, 500. Royal Assent, 631.—63-64 Victoria, Chapter 57.

Read second time; considered in Committee of the Whole; reported; read third time; passed, 782. Passed by Senate, 837. Royal Assent, 911.—63-64 Victoria, Chapter 24.

Read second time and referred to Committee on Miscellaneous Private Bills, 192. Reported amended; fees refunded (not liable), 245. Considered in Committee of the Whole; reported; read third time; passed, 257. Passed by Senate, 436. Royal Assent, 630.—63-64 Victoria, Chapter 96.

Considered in Committee of the Whole; reported; read third time; passed, 756. Passed by Senate, 802. Royal Assent, 911.—63-64 Victoria, Chapter 25.
