# POLLUTION THREAT TO WINNIPEG WATER SUPPLY—MOTION UNDER S.O. 43

Mr. Bill Blaikie (Winnipeg-Birds Hill): Madam Speaker, the entire water supply of the city of Winnipeg is endangered by the commencement of construction of a sewage lagoon near Shoal Lake, Ontario. The Minister of Indian Affairs and Northern Development (Mr. Munro) has a responsibility in this matter as it is the action of an Indian band which is at issue.

The provincial minister of environment in Manitoba has repeatedly contacted the Minister of Indian Affairs and Northern Development about this matter but has received no reply. Therefore I move, seconded by the hon. member for Winnipeg North (Mr. Orlikow):

That this House demonstrate its concern for the health of the people of Winnipeg and instruct the Minister of Indian Affairs and Northern Development to ensure that he takes every step to ensure that the water supply of Winnipeg is never endangered in this way and that he immediately consult with the minister of the environment in Manitoba as to what he should be doing to help in this regard.

# **UNEMPLOYMENT INSURANCE**

ELIGIBILITY OF PREGNANT WOMEN—MOTION UNDER S.O. 43

Hon. Flora MacDonald (Kingston and the Islands): Madam Speaker, I rise under the provisions of Standing Order 43 on a very urgent matter. On June 25 a ruling which discriminates against women who are pregnant was upheld in the Federal Court of Appeal. A woman who was critically ill was declared ineligible for unemployment insurance sick benefits because she was six months pregnant. The judge noted that had the provisions in the new Charter of Rights been fully implemented, such a ruling would not have taken place. Therefore I move, seconded by the hon. member for Simcoe North (Mr. Lewis):

That instead of waiting three years until the Charter of Rights automatically makes invalid Section 46 of the Unemployment Insurance Act which prohibits pregnant women from collecting unemployment insurance payments other than maternity benefits, the federal government take immediate steps to delete Section 46 from the act to prevent further discrimination on the basis of pregnancy.
