58. Resolved, That a sum not exceeding Four hundred dollars be granted to Her Majesty, for Minor Revenues—Department of Inland Revenue, for the year ending 30th June, 1897.

59. Resolved, That a sum not exceeding One thousand two hundred and five dollars be granted to Her Majesty, for Ordnance Lands, including amount required to pay expenses in connection with the repairs to roads at Grand Falls, New Brunswick, for the year ending 30th June, 1897.

The said Resolutions, being read a second time, were agreed to.

Mr. Brodeur reported from the Committee of Supply several Resolutions; which were read, as follow:—

1. Resolved, That a sum not exceeding Three millions two hundred thousand dollars be granted to Her Majesty, for Intercolonial Railway, for the year ending 30th June, 1897.

2. Resolved, That a sum not exceeding Two hundred and forty-five thousand dollars be granted to Her Majesty, for Prince Edward Island Railway, for the year ending 30th June, 1897.

3. Resolved, That a sum not exceeding Twenty thousand dollars be granted to Her-Majesty, for Windsor Branch Railway, for the year ending 30th June, 1897.

4. Resolved, That a sum not exceeding Five hundred and thirty three thousand nine hundred and twenty dollars be granted to Her Majesty, for repairs and working expenses--Canals, for the year ending 30th June, 1897.

5. Resolved, That a sum not exceeding Fifty-eight thousand dollars be granted to Her Majesty, for Canals, as follow :—Salaries and contingencies, Canal Office, \$43,000 : Additional pay to persons permanently employed in the Public Service and remuneration to any other persons for services rendered for, and in connection with, passing vessels through the Canals of the Government of Canada, from midnight on Saturdays to midnight on Sundays (notwithstanding anything to the contrary in the Civil Service Act), \$15,000, for the year ending 30th June, 1897.

6. Resolved, That a sum not exceeding Three millions seven hundred and sixtysix thousand four hundred and fifteen dollars be granted to Her Majesty, for Post Office, as follow:—Mail Service, \$2,336,000; Salaries and Allowances \$1,223,295; Miscellaneous \$207,120, for the year ending 30th June, 1897.

7. Resolved, That a sum not exceeding Three thousand five hundred dollars be granted to Her Majesty, for Department of Trade and Commerce—To provide for the administration of the Chinese Immigration Act, including remuneration to Trade and Commerce and Customs officers, for the year ending 30th June, 1897.

8. Resolved, That a sum not exceeding Six hundred dollars be granted to Her Majesty, to meet Canada's proportion of expenditure in connection with the International Customs Bureau, Brussels, for the year ending 30th June, 1897.

9. Resolved, That a sum not exceeding Fifteen thousand dollars be granted to Her Majesty, for Commercial agencies, including expenses in connection with the negotiation of treaties or in extension of commercial relations, for the year ending 30th June, 1897.

10. Resolved, That a sum not exceeding Four thousand dollars be granted to Her Majesty, to pay salary of Dominion Lands Commissioner, for the year ending 30th June, 1897.

11. Resolved, That a sum not exceeding Three thousand dollars be granted to Her Majesty, to pay Superintendent of Mines' salary, for the year ending 30th June, 1897.

12. Resolved, That a sum not exceeding Two thousand dollars be granted to Her Majesty, for Inspector of Agencies' salary, for the year ending 30th June, 1897.

13. Resolved, That a sum not exceeding One thousand eight hundred dollars be granted to Her Majesty, for Secretary's salary (Dominion Lands), for the year ending 30th June, 1897.

14. Resolved, That a sum not exceeding Eight thousand four hundred dollars be granted to Her Majesty, to pay Homestead Inspectors' salaries, for the year ending 30th June, 1897.
