MESSAGE from the COUNCIL.

Mr. Justice *Saunders* delivered the Message.

Mr *Speaker*,

“The Council have agreed to the Resolutions of Supply sent up this day;” and then Mr. *Saunders* withdrew.

Read a second time, a Bill to erect into a Town or Parish, the Settlement on the Washademoac River, commonly called New-Canan settlement.—Ordered to be committed.

Read an engrossed Bill to enable the Minister and Elders for the time being of the Church in Communion with the Kirk of Scotland, lately erected in the City of Saint John, to hold the same to them and their successors for ever, and for other purposes in the same mentioned.—Resolved that the Bill do pass.

Ordered that Mr. *W. Pagan* and Mr. *Johnston*, do carry up the Bill to the Council and desire their concurrence.

Resolved that an humble Address be presented to His HONOR the PRESIDENT, requesting that His HONOR will be pleased to give directions for the running of the Boundary Line between King's and Queen's Counties; the Boundary Line between Westmoreland and King's and Queen's Counties; the Boundary Line between Saint John and King's Counties, and the Boundary Line between St. John and Westmoreland, or so much thereof as may be considered necessary for the present, and that the House will at the next session, make provision for defraying the expence thereof—Ordered that Mr. *Attorney General*, Mr. *Botsford* and Mr. *Johnston*, do present the same Address.

The House in Committee, Mr. *R. Pagan* in the Chair, went into consideration of a Bill to erect into a Town or Parish, the settlement on the Washademoac River, &c.

The *Speaker* resumed the Chair.

Mr. *R. Pagan* from the Committee, reported that he was directed by the Committee to report that they had gone into consideration of the Bill before them, under the title of a Bill to erect into a separate Parish, all the Lands in Queen's County, in the rear of the Parishes of Wickham and Waterborough—and he delivered the Bill at the Clerk's table; which Bill being read was ordered to be engrossed.

The House then adjourned until to-morrow morning at 11 o'Clock.
