

To the Rector, Church Wardens, and Vestry, of the Church in the Town of St. Andrews, the sum of £100, towards building a Parsonage House, in aid of individual subscription for that purpose.

To His Excellency the Lieutenant-Governor, the sum of £100, to be expended by Commissioners to be appointed by His Excellency, in aid of a subscription of £106 : 15, towards repairing the Church in the Parish of Burton, in the County of Sunbury.

To the Stewards of the Methodist Chapel in the City of St. John, the sum of £200, to assist them in paying off the heavy debt incurred by them in building the same.

To the Church Wardens and Vestry of the Parish of Hampstead, in Queen's County, the sum of £150, in aid of individual subscription, towards building a Church in that Parish.

To the Committee and Elders of the Presbyterian Church in Sheffield, the sum of £100, to reimburse them in part for the extraordinary expense they have incurred in finishing their Meeting-House in Sheffield.

To John Colwell, Esq. and other Petitioners in behalf of the Baptist people in Queen's County, the sum of £100, to aid their subscription and deposit of cash of £239 : 15, to enable them to build a suitable place of worship in their neighbourhood, where there is no Church established.

To the Stewards and Trustees of the Methodist Chapel in Sheffield, the sum of £50, to assist them in repairing and finishing their Chapel.

To the Wardens and Vestry of the Parish of Mougerville, for the time being, the sum of £50, in aid of £100 already subscribed, for completing the Parsonage House and Church in that Parish.

To Henry Cronkite and Amos Dow, the sum of £25, to enable them to finish a small building lately erected in the Parish of Northampton, to accommodate the Inhabitants in the upper part of that Parish, at their public worship.

To the Deacons and Committee of the Baptist Church in the City of St. John, the sum of £200, to assist them in paying the heavy debt incurred in building said Church.

Mr. *M'Kay* moved for leave to bring in a Bill, "to enable the Minister and Elders, for the time being, of the Church in Communion with the Kirk of Scotland, lately erected in the Parish of Sheffield, in the County of Sunbury, to hold the same to them and their Successors for ever, and for other purposes therein mentioned."

Leave granted.

Mr. *Millidge* had leave of absence.

The House then adjourned until Monday morning next, at ten o'clock.
