The eleventh to the sixteenth Resolutions inclusive, being read a second time, were agreed to.

Ordered, That the Honorable Mr. Galt have leave to bring in a Bill to amend the Acts respecting Duties of Customs, and the Tariff of Duties payable under them.

He accordingly presented the said Bill to the House, and the same was received and

read for the first time; and ordered to be read a second time, to-morrow.

A Message from the Legislative Council, by John Fennings Taylor, Esquire, one of

the Masters in Chancery:

Mr. Speaker,—The Legislative Council request that this House will furnish their Honors with the evidence, proofs and documents, upon which is founded the Bill, intituled, "An Act to authorize William John Bickell to construct a Bridge over the River St. "Charles," together with all Petitions and other documents against the said Bill, and that the same be furnished to the Committee of the Legislative Council on Standing Orders and Private Bills.

Bill, intituled, "An Act for indemnifying the Members of the Executive Government " and others, for the unavoidable departure from the provisions of the Audit Act, occa-" sioned by the necessity of maintaining a large Militia Force on active duty on the "Frontier, in the years 1865 and 1866."

And also, the Legislative Council have passed the Bill, intituled, "An Act respecting " the hearing of Causes in the Court of Chancery for Upper Canada," with an amendment,

to which they desire the concurrence of this House.

And then he withdrew.

The House proceeded to take into consideration the Amendment made by the Legislative Council to the Bill, intituled, "An Act respecting the hearing of Causes in the Court "of Chancery for *Opper Ganada*," and the same was read, as followeth:

Page 1, line 19,—After "Court," insert as a portion of the next succeeding section :

"The Counsel may give his decision either during the sitting or afterwards, and."

The said Amendment, being read a second time, was agreed to.

Ordered, That the Clerk do carry back the Bill to the Legislative Council, and acquaint their Honors that this House hath agreed to their Amendment.
