## INCREASED DEFICIT IN BALANCE OF PAYMENTS

On the orders of the day:

**Hon. George C. Nowlan (Digby-Annapolis-Kings):** Mr. Speaker, in view of the fact that the Minister of Finance has informed us that he just returned last night he may not be conversant with the figures released this morning by the dominion bureau of statistics with respect to our balance of payments position, and the rather surprising increase in our deficits in the quarter just past as compared with the same quarter last year. The minister may have information with respect to that, but I would appreciate it if he would
