The government, of course, is always considering improvement of the fitness and amateur sport program. As my hon. friend knows, each year another \$1 million is added until the \$5 million originally planned has been expended. It is obvious that even when the \$5 million is reached this will be insufficient to provide all the money necessary for capital works or for other uses to which money might be put, but the fact is that the government is from time to time giving increasing attention to the possibility of expanding this program.

Mr. Harold E. Winch (Vancouver East): Mr. Speaker, what did the hon. member mean by "unexpected" when it is Vancouver that is involved? Our athletes have won a gold medal and a bronze medal.

Mr. Aiken: A supplementary question, Mr. Speaker. Is the minister aware that in both cases, the bobsled team last winter and the rowing team this fall, the participants had difficulty in getting themselves and their equipment to the Olympics?

Miss LaMarsh: Yes, Mr. Speaker, but that obviously did not deter them from carrying off the highest awards, and this situation is far from unique to Canada.

Mr. Erik Nielsen (Yukon): A supplementary question, Mr. Speaker. Can the Minister of Justice advise the house whether the government is planning to give Hal Banks a gold medal for bail jumping?

The minister said he had answered this question two days ago. I have checked Hansard very carefully, and this is the first opportunity I have to bring the matter to Your Honour's attention. My question was entirely different from the question put to the minister two days ago by the hon. member for Winnipeg North and the hon. member for Kootenay West. The minister has tried to mislead the house. He has been evasive and, above all, he has been most arrogant in his evasion so far as this matter is concerned. It is arrogance of the worst kind.

VANCOUVER—POSSIBLE USE OF FORMER R.C.A.F. BASE
