COUNTRIES PARTICIPATING IN EXPO '67

Question No. 518-Mr. Martineau:

1. Is a revised contract being presented for signature to the national representatives of some 30 governments taking part in Expo '67?

2. If so, why is such a revised contract being presented to these representatives?

3. When are the participants in Expo '67 expected to sign binding instruments in regard of such participation?

4. How many countries have been invited to participate in Expo '67 and how many have accepted to date?

Hon. Mitchell Sharp (Minister of Trade and Commerce): 1. The original version of the standard participation contract was submitted in April 1965 to a Commission of the International Bureau of Exhibitions. It was then suggested to the Corporation to remove from this version the provisions of a regulatory nature and embody the same into the various sets of special rules and regulations which the General Rules and Regulation of the B.I.E. call for. This suggestion was accepted and this explains why the contract was revised.

2. See answer to question 1.

3. Some countries have already signed the standard contract while many have already scheduled the signing ceremony. The contract was distributed to all governments represented at the Meeting of Commissioners General of Section which took place in Montreal from May the 19th to the 22nd. They have all expressed their wish to sign a contract with the least possible delay after clearing the same with their own government. Even in the absence of a signed binding document, the governments that have announced their participation are presently working on the plans of their pavilion.

4. 139 countries were invited to participate in Expo '67. To date, 51 countries including Canada have accepted and it should be noted that the 10 Canadian provinces, the cities of Paris and Montreal, and the European Common Market, will also participate.
